1. Definitions

In this warranty the following terms shall have the following meanings:

Jetmall.net	Shall mean Jetmall.net Inc.
Jetmall.net Product	Shall mean the Jetmall.net Product
Warranty Period	Shall mean a period of one year (365 days) from the original date of purchase as new
Extended Warranty Period	Shall mean the period of the Jetmall.net Extended Warranty, beginning on the first day of expiration of original warranty period, and valid for the period purchased

2. General

Jetmall.net Extended Warranty is an extension of your original warranty. Jetmall.net Extended Warranty expires upon the anniversary of the original date of purchase of the Jetmall.net Product, and must be contiguous. Jetmall.net Extended Warranty purchase, registration and activation must be completed before any Warranty or Extended Warranty has expired. The terms and conditions of Jetmall.net Warranty for the Jetmall.net Product and any supplementary information on Jetmall.net Extended Warranty (including products covered and maximum period of Jetmall.net Extended Warranty) can be viewed on www.Jetmall.net Click on Support then extended warranty

3. Warranty

During the Extended Warranty Period Jetmall.net will, at its discretion, repair or replace any defects in the Jetmall.net Product free of charge. Repair, parts or replacement of the Jetmall.net Product will be furnished either on a pickup and return basis and will be either new or refurbished to be functionally equivalent to new. The warranty in respect of a repaired or replaced item shall be for the remainder of the Extended Warranty Period. All original items replaced in the performance of services shall become the property of Jetmall.net and the new or replacement parts will become the property of the Customer. The method of service will be as described in the original warranty statement provided with the Jetmall.net Product. Jetmall.net makes no representation or warranty that the Jetmall.net Product will operate uninterrupted or error free.

The following special conditions apply to the Jetmall.net Extended Warranty:

- a. Batteries, accessories, consumables and consumable replacement parts are excluded from the Jetmall.net Extended Warranty. HDD is considered a consumable replacement part, therefore it is not covered by extended warranty service.
- b. Jetmall.net is not responsible for any cost incurred during shipment of return product(s) to Jetmall.net. Jetmall.net ships, at its expense, repaired/replaced product(s) back to customer after servicing product(s).
- c. Extended warranty is valid within the continental United States of America (lower 48 contiguous states and the District of Columbia), and Canada.
- d. Defects reported outside of the Extended Warranty Period are excluded.
- e. Extended warranty must be purchased with new iAUDIO/COWON Player(s).
(Can not be purchased separately or at a later time.)

Services performed by Jetmall.net in rectifying damage or defect caused as a result of any excluded conditions shall be subject to additional charges for labor, transportation, and parts.

4. Cancellation

The customer may cancel this contract at any time. The Jetmall.net shall refund full amount of the cost of extended warranty paid by the customer if cancellation is made within 30 days from the date of purchase. The Jetmall.net shall apply following fees to cancellation of Jetmall.net extended warranty aged older than 30 days:

- a. Administrative fee of up to \$25.
- b. amortization: prorated amount of the original cost for the period the jetmall.net extended warranty is in effect.
